Consultation on due diligence on forest risk commodities

Dear consultee,

I am writing to invite your views on Defra's proposals for implementing provisions in the Environment Act to tackle illegal deforestation in UK supply chains.

The due diligence provisions will make it illegal for larger businesses operating in the UK to use key 'forest risk' commodities (agricultural commodities associated with wide-scale deforestation) that were produced on land illegally occupied or used.

Secondary legislation is required to implement these provisions. We are launching this consultation to seek the views of interested parties to inform the effective design of this legislation and accompanying guidance. The following documents may be found on GOV.UK:

Consultation criteria

This consultation will last for 14 weeks. It builds upon the UK Government's world-leading legislation recently introduced through the Environment Act to tackle illegal deforestation in UK supply chains.

The Environment Act provisions will make it illegal for larger businesses operating in the UK to use key 'forest risk' commodities that were produced on land illegally occupied or used. Businesses in scope will also be required to undertake a due diligence exercise on their supply chains, and to report on this annually.

To ensure transparency, information about businesses' due diligence exercises will be published. Businesses in scope that do not comply with these requirements may be subject to fines and other civil sanctions.

This is one part of the UK Government's wider package of measures to improve the sustainability of our supply chains and will contribute to global efforts to protect forests and other ecosystems.

The secondary legislation and accompanying guidance will specify:

- which commodities will be in scope of regulations
- which businesses will be subject to provisions
- what businesses in scope will be required to undertake and report on regarding their due diligence exercise
- how the requirements will be enforced
